CareHouse Services

CareHouse Family Time & Safe Exchange Program offers a child-friendly, safe, and welcoming environment which provides an opportunity for families to participate in a variety of supportive services. These include both in-person and virtual supervised family time, monitored sessions, and safe exchanges. All services are facilitated by one of our dedicated CareHouse Team. Each service is designed to nurture parent-child relationships while prioritizing safety and emotional well-being of every family member.

Safety and Support

A trained Family Time Specialist is present at all times to observe and factually document parent—child interactions and intervening only when necessary to ensure the safety and well-being of all participants. Additionally, a member of the CareHouse Team is there to provide support and help ensure peaceful transitions during safe exchanges. To maintain a safe and secure environment, arrival and departure times are carefully staggered by 15-minute intervals to prevent contact between parties.

Setting Up Services

- Apply: All parties must complete a CareHouse Application packet and include any court orders, if applicable.
- 2. Phone Intake: Once all applications have been received, separate phone intakes will be scheduled with each party.
- 3. Scheduling: Please allow 7–10 business days after intakes for scheduling. The schedule will be based on everyone's availability, as well as CareHouse scheduling capacity. After school and evening appointments are limited.

While at CareHouse

- Share a meal in our kitchenette
- Have a picnic or playtime at a nearby park
- Spending time together in one of our child-friendly rooms
- Take a short walk and browse at one of the nearby stores
- Explore a nearby museum
- Enjoy eating at one of the restaurants within walking distance

*All off-site activities are supervised by a Family Time Specialist, weather permitting, and take place only with approval from the Court, Program Manager, or Coordinator.

Important Reminders:

- The non-residential parent MUST CONFIRM 24-hours prior to each scheduled session to avoid cancellation.
- All parties must agree and adhere to CareHouse guidelines.
- Copies of Parenting Time Summaries are available monthly for a fee. CareHouse does not provide documents directly to the courts.
- To protect everyone's safety and ensure compliance with CareHouse policies and protection orders, please arrive at your scheduled time. Non-residential parties arrive first, and the children arrive 15-minutes later to support a safe, calm transition.

Closed Fridays - Sundays and all holidays.

All services are by appointment only.

Supervised Virtual Time | \$35/half-hour

Monitored Family Time | \$30/hour

Intake | \$25 (one-time fee for each party)

Safe Exchange | \$20

*For qualifying families, financial assistance is available for In-Person Supervised Family Time.
